Course Description and Requirements

The purpose of this portion of the course is to provide a selected survey of topics in labor economics including: human capital, estimating the returns to education, discrimination, and unions, to name a few. The course will focus on empirical work designed to test microeconomic theories of labor markets.

The grade for the course will be determined by an exam given at the end of the semester and the paper. The exam counts for a third of the final grade and the paper counts for two-thirds. The paper should contain an empirical section with estimates from a microdata set. I will give you more details about the requirements for the paper early in the semester. In addition, students will be expected to present a selection of papers on the syllabus in class, and to write a referee report.

The course has four main goals: to introduce some of the current issues in labor economics, to increase familiarity with the common econometric techniques used in labor economics, to increase knowledge of the data sources, and to help students start thinking about research topics in labor economics.
